Payment Options:

- Payment/Module Payment will be received no later than the 1st of each month of the module (\$200.00 deposit with application, FYI \$375.00 Mod 1,2 & 3 – 200hr Module 1, 3, 4 & 5 -\$550.00/month)

All payment options must be approved by Training Division Leader Shirley Berthelet. A 50% discount is offered for former graduates wishing to repeat their training.

An electronic version of the training manual is included in the cost of tuition. Pose manuals for Level 1 (FYI training) & Level 1-2 (Inspiritus Module 5)

Cancellation and Refund Policy:

In the event that Inspiritus Yoga cancels training or a module, all applicable fees will be refunded in full.
